### **European Higher Education Area:**


present achievements and future challenges

*Since the very beginning of the Bologna Process in 1999, Italy has always supported it strongly as the main framework for the progress and consolidation of mutual cooperation in European Higher Education, and as a fundamental tool for spreading democratic values and enhancing dialogue among countries. These are also the reasons for the Italian candidature to host the Secretariat of the Bologna Follow up Group (BFUG) from 2018 until 2020 and to organize in Italy the Eleventh Ministerial Conference of the European Higher Education Area.*

*2020 will be a crucial year, both for the European Agenda and for the celebration of the first twenty one years of the most relevant international process dedicated to Higher Education. ## Consolidating the EHEA in Italy

The “CHEER” projects are a fundamental tool for supporting the consolidation of the EHEA reforms in the Italian higher education system:

### **Consolidating Higher Education Experience of Reform (CHEER): norms, networks and good practice in Italy**

- *coordinated by the MIUR – Department of Higher Education and Research – General Directorate for Students, Development and Internationalization of the Higher Education;*
  - *co-financed by the European Commission under the Erasmus+ KA3 (Policy Support Action), and managed by the CRUI – Conference of Italian University Rectors;*
  - *Involving the key national stakeholders.*

## The CHEER projects

- Develop a strong **systemic synergy** among the main national actors concerned with HE policies, involving them directly in the project activities and in supporting and implementing the project results;
- maintain contacts and synergies with **international bodies** concerned with HE, in order to link national and European policies;
- enhance the quality of the **international dimension in HEIs** (Universities + Fine Arts and Music Institutions) also promoting **the widespread use** of the European transparency tools;
- valorize a **student-centered approach** in the implementation of the EHEA reforms, including those indicated in the Yerevan Communiqué.

## The goals of CHEER I

### Implement the EHEA policies and tools

at national and institutional level to achieve the European reforms in a substantial – rather than in a formal – way.

### Strengthen dialogue and collaboration

among various actors and stakeholders.

- **Students** ▶ participate constructively in the reform process, with awareness of their role, and through specific training.
- **Professors** ▶ reflect more deeply on some key topics and find shared solutions to implement policies and tools.
- **HE Institutions** ▶ implement an effective use of the transparency tools; devote adequate funds/resources to developing international strategies.

### Actions

- Cooperation with national policy makers to define optimal implementation strategies;
- Dissemination of the most relevant EHEA documents;
- Production of guidelines, recommendations and tools for the HEIs;
- Consolidation of national networks and interaction among them.

### Key topics

- Employability of graduates in Fine Arts and Music HEIs
- Joint programmes
- Quality assurance
- Recognition of qualifications
- Student-centred learning
- Student participation



## The goals of CHEER II


**Integrate** the various aspects of the reform process into one consistent and well-functioning **learner-centered system** at the institutional, national and international level.

**Guarantee** and enhance the **quality** of the main **transparency tools** (DS, ECTS Course catalogue); of student and staff **mobility**; of **joint programmes**.

The correct use of transparency tools requires **clear policies** and well **organized information systems** at the institutional level. It also benefits from **guidelines** and **quality assurance** measures at the national level. At the same time, it makes international communication and collaboration smoother, thus enhancing the **quality** of student and staff **mobility** and of **joint programmes**.

**Actions.** To ensure a strong systemic synergy, the four topics are being developed by **4 ad hoc Working Groups**, composed of the key stakeholders, which will produce concrete tools and recommendations for both the HEIs and policy makers.

**Key topics.** This project focuses on **four among the main challenges** pointed out in the Bologna Implementation Report 2015:

- Diploma Supplement
  - ECTS Course Catalogue
  - International and joint programmes
  - Mobility

## Overall expected impact

### **MODERNIZATION OF THE HE SYSTEM:**

the CHEER projects are part of an articulated set of actions planned by the Ministry for HE (MIUR) to develop and modernize the Italian HE system as a whole. The project is expected to have a major impact at the national level through the formal inclusion in the national legislation of the recommendations and tools produced by the Experts and the WGs.

**MULTIPLIER EFFECT:** working at different levels (national, institutional, individual) and creating mutually reinforcing positive synergies will lead to a multiplier effect on both the normative framework and its practical implementation.
